- v) In Hockey, for recruitment against the posts having Grade Pay Rs.1900 or Rs.2000 in Pay Band Rs.5200-20200, at least 2<sup>nd</sup> position in the International Tournaments of four or more nations, may be also be considered.

#### 6. Examination Fee

a)	The examination fee for all candidates except those mentioned in para (ii) below.	Rs.500/- (Five Hundred only) with a provision for refunding Rs.400/- to those who actually appear in the trials.
b)	For candidates belonging to SC/ST/Ex-Servicemen, Minorities and Economically Backward Classes.	Rs.250/- (Two Hundred and Fifty only) with a provision for refunding the same to those who actually appear in the trials.

#### Note:

- (i) The examination fee is not refundable/transferable/adjustable under any circumstances, in respect of those candidates who do not fulfil the eligibility criteria but still have applied for recruitment, in response to this notification.
  - Certificate in proof of the above, issued by the authorities authorized to issue such certificate should be enclosed along with the application form for getting relaxation in the application fee. Candidates should check their eligibility thoroughly before applying. Examination fee paid in respect of candidates who are ineligible, but still apply, shall not be refunded.
- (ii) While applying, the candidates claiming fee exemption must submit necessary certificates i.e. SC/ST/Ex-Servicemen/Minorities/Economically Backward classes (EBCs), in the format prescribed (i.e. Annexure A, B, C, D).

- (b) Sitting Member of Parliament of Lok Sabha for persons of their own constituency.
- (c) BPL card or any other certificate issued by the Central Government under a recognized poverty alleviation programme or Izzat MST issued by Railways.
- (d) Union Minister may also recommend for any persons from anywhere in the Country.
- (e) Sitting Members of Parliament of Rajya Sabha for persons of the district in which these MPs normally reside.
- (f) The income certificate issued by the authorities mentioned above would have to be in the format prescribed at Annexure D. This would have to be issued on the letter head of the issuing authority.
- (vii) The examination fee should be paid in the form of crossed Indian Postal Order (IPO)/ Demand Draft (DD) only, from any Post Office/Nationalised Banks drawn in the favour of Principal Financial Adviser (PFA), Rail Wheel Factory, Yelahanka, Bangalore-560 064, payable at Bangalore.
- (viii) Remittance of examination fee in any other form except Indian Postal Order/Demand Draft will not be accepted.
- (ix) IPOs/DDs issued before the date of issue of Employment notice or after the closing date will not be accepted and the application will be rejected.
- (x) The particulars of Indian Postal Order/Demand Draft submitted, as examination fee should also be indicated at the prescribed place in the application form.
- (xi) Candidates must write their name, full address in the space provided in the Indian Postal Order.

#### 7. (I) Selection Procedure

- of the candidates shall be conducted to assess their sports performance and suitability. After the trials, only the FIT candidates shall be considered for the next stage i.e interview stage. Candidates declared "NOT FIT" in the trials will not be assessed by the Recruitment Committee.
- ii) The dates for trials will be notified later and published in the RWF website to be held at Rail Wheel Factory Stadium, Yelahanka, Bangalore –560064 or at notified place. While all out efforts will be made to inform the candidates well in advance, the candidates are cautioned that they may have to appear in the selection trials at short notice. Note:- The offer of appointment shall be given purely on the basis of merit. In case more than one sportspersons score the same marks, preference will be given to younger candidate to decide the merit.

## (IV) Proficiency in Typing Skill

The sportspersons recruited as Clerk or Senior Clerk against sports quota, should pass the requisite type-writing test within a period of four years from the date of their appointment. If a sportsperson is unable to pass the type-writing test within the period of four years, the regular increments due on completion of four years and thereafter, will not be released.

#### 8. Medical Examination

The sportsperson shall fulfil the minimum medical norms for the post, for which he is being appointed.

#### 9. "Service Bond" for persons recruited against Sports Quota

The "Service Bond" period for the persons recruited against Sports Quota shall be of five years. At the time of his appointment, the sports persons shall fill and sign the Bond in the format attached at Annexure – E. In terms of provision of para 3 of Annexure-E (Service Bond) those recruited against sports quota can participate in any of the sports activities other than those of the Government including professional Games/Leagues only with previous sanction of the Government.

#### 10. HOW TO APPLY

- The notification with the application form and other Annexures are available in Rail Wheel Factory website <a href="www.rwf.indianrailways.gov.in">www.rwf.indianrailways.gov.in</a>. The candidates should carefully read the instructions before filling up application form. Application form (Annexure-I) should be printed on a good quality, white A-4 (210 X 297 mm) size paper, ONE SIDE ONLY. The candidates should use the same format as available along with notification in the website.
- ii) The candidate has to fill the required information in his own handwriting using blue ball point pen. The application should be filled either in English or Hindi but not in any other language. Application filled in any language other than English/Hindi and having any deviation from the prescribed format of the application will lead to rejection of application summarily.
- one recent passport size photo (4 cm x 5 cm) preferably not older than 3 months should be affixed on the application form without fail. The photo should clearly reveal the full face and should be taken without wearing goggles/coloured glasses. Photos should be sharp and clear, with light background, suitable for scanning and printing. Do not put any marks or signature on the front side of the affixed photograph. The photograph should be neatly and firmly pasted in the prescribed space, and not stapled or pinned. Photograph should not be attested by anybody including the candidate.
- iv) Candidates are required to sign in English/Hindi at prescribed places provided in the application form.
- While filling up the application, candidates have to ensure that the signatures and two marks of physical identification (e.g a mole on the nose, cut mark on the forehead in the left side or a scar mark below the left arm etc) are clearly given without fail.
  - Candidates should also give Left thumb impression in the application form. If the LTI's are not clear and are smudged, the application will be liable to be rejected.

- vii) Candidate should clearly indicate the specific sports discipline, event and position applying for as given in para 1. [eg Hockey (Men), Mid Fielder or Forward].
- viii) Candidate should submit their applications as at Annexure-I along with requisite enclosures so as to reach this office on or before the closing date and time. Railway administration shall not be responsible for any postal delay. All applications received after the closing date and time will be summarily rejected.
- ix) All the copies of the certificates shall be self-attested.
- Candidates should also note that the <u>sports achievements</u> and <u>educational</u> <u>qualification</u> for which self attested copies of certificates are enclosed along with the application will only be considered for ascertaining eligibility for recruitment.
- candidates should note that he is required to produce the originals of all documents pertaining to educational qualification, caste, sports achievements, date of birth, minority income certificate etc at the time of selection trials.
- xii) If there is any change in the address, the candidate in his own interest should arrange with the Post Office concerned for redirection of the communication from old to new address.
- xiii) Candidate should write his name, Father's Name in Capital letters as given in Matriculation/High School Examination certificate.
- xiv) Candidates should indicate Religion, Gender (Male/Female), Community (UR/SC/ST/OBC), Serving Employee and other information in the relevant columns of the application form.
- Before applying for a post, the candidates should ensure that they fulfil the eligibility criteria stipulated for the post. The Railway Administration would be at liberty to reject any application not fulfilling the prescribed criteria at any stage of recruitment.

- Applications without photographs or with photographs with coloured (vii) glasses/cap
- Applications received after closing date. (viii)
- Application not addressed to the concerned Office/Officer. (ix)
- Applications where self attested copies of the required certificates are not (x) enclosed.
- Any other discrepancies noticed in the application at any time during the (xi) recruitment process would render the candidate ineligible.

#### 12. General Instructions

- (i) Canvassing in any form shall disqualify the candidature.
- Candidates are advised to indicate their active mobile number and valid e-mail ID (ii) in the application form and keep them active during the entire recruitment process as all important messages will be sent by e-mail/SMS which will be treated as deemed to have been read by the candidate.

- (v) Applicant should possess the prescribed minimum educational qualification and sports achievements on the date of submission of application.
- (vi) SC/ST candidates will be eligible for free Rail travel in second class for attending sports trials/interview.
- (vii) Candidates may download the recruitment notification and application form available on Rail Wheel Factory website <a href="www.rwf.indianrailways.gov.in">www.rwf.indianrailways.gov.in</a>
- (viii) The decision of RWF Administration in all matters relating to eligibility, acceptance or rejection of the application, issue of free Rail passes, penalty for false information, mode of selection, conduct of trials/interview, selection, allotment of post to selected candidates etc. will be final and binding on the candidates. (xxiii) Candidates selected through sports quota will have to perform in his field of sports for a minimum period of 5 years.

#### 14. Caution/Important Advisory

Recruitment is purely merit based. RWF have not appointed any agent or coaching centre for acting on its behalf for this recruitment. Candidates are cautioned against any false claims made by any unscrupulous persons/agencies of getting them selected in this recruitment process on illegal considerations.
